

1 A. That's what a nurse, I believe, gave a ventilator for.

2 Q. Your mother had a mask that they gave her for the --

3 A. Yeah.

4 Q. -- asthma, correct?

5 A. That's correct.

6 Q. And they prescribed medication for the asthma, correct?

7 A. It was -- I don't remember what it was called. I don't  
8 remember. I'm sorry.

9 Q. In spite of that, though, your opinion was you didn't  
10 think your daughter had asthma?

11 MR. WALSH: Objection. Argumentative.

12 THE WITNESS: That's correct.

13 THE COURT: Overruled.

14 THE WITNESS: That's --

15 THE COURT: The answer was, that's correct. Jury can  
16 consider that.

17 THE WITNESS: Yes.

18 Q. (By Mr. Brown:) Now, talk to you for a minute, do you  
19 recall telling Mr. -- do you recall using a chemical in your  
20 Broken Arrow address?

21 A. I don't recall.

22 MR. BROWN: Your Honor, I'm going to -- if it please  
23 the Court, I need to find this one interview, please.

24 THE COURT: Take your time.

25 MR. BROWN: It might take a moment, your Honor. I  
26 apologize.

27 THE COURT: Okay.

28 (BRIEF PAUSE IN PROCEEDINGS.)

1 Q. (By Mr. Brown:) Do you recall telling Mr. Brad- --  
2 excuse me. Strike that.

3 Do you recall telling Mr. Mickey that, Jennifer was  
4 sleeping a lot, I wonder if it was the carpet cleaner?

5 A. I don't recall saying that.

6 Q. Do you recall then Mr. Mickey asking you, the what, and  
7 then you telling him, the cleaner from the carpet?

8 A. No, I'm sorry.

9 MR. BROWN: May I approach, your Honor?

10 THE COURT: Yes.

11 MR. BROWN: Page 5, Counsel.

12 Q. (By Mr. Brown:) Show you the question, ask you to read  
13 it right here.

14 A. I'm sorry.

15 Q. Right there.

16 A. Okay.

17 Q. You've had an opportunity to read that?

18 A. Yes.

19 Q. Does it refresh your recollection as to whether you  
20 told Mr. Mickey that you had used carpet cleaner in the  
21 apartment?

22 A. If it says that I said that, then I said that. But I  
23 don't remember saying that. I don't remember. But if I said  
24 that, then obviously I said that.

25 Q. So you did say that you had used the carpet cleaner?

26 A. That's what it says.
